



## Report about killing four Iraqi civilians in their house in Al-karama quarter in Mosul at 29/3/2007

### The detail of the harmful incident :

In the morning of Thursday failing on 29th of march 2007 the I.O.H.R. had told about critical incident that is the multi-national forces had attacked with fire and bombs and (dogs) the victim's house (MR. Zewar Mohammad Khalil) at two o'clock after midnight . The house is located in Al-karama 18 quarter in Mosul . So , the watching and documentation committee had gone to the incident place quickly and interviewed with victim's wife (MR. Zewar Mohammad Khalil) whom declared that she had woken up on explosive sounds at 2:30 o'clock after midnight then she had astonished by multi-national soldiers nearly (10 - 15) soldiers inside the house , they attacked the house with fire and bombs and explosive all the doors then they entered the first room which the father was sleeping there (MR. Zewar Mohammad Khalil) then they fired guns at his head directly when he was still sleeping in his bed with his wife then they went to the another room which their sons were sleeping and the same thing , they fired guns at their heads directly what our committee had watched and documented also , it had seen the blood and brains of the victims on their beds where they were sleeping .

### The killed victims are :

1. Zewar Mohammad Khalil – born at 1948 , he is worker and he has a shop ( the father ) .
2. Khalid Zewar Mohammad Khalil – born at 1983 , he is a student in nursing secondary school .
3. Mohammad Zewar Mohammad Khalil – born at 1987 , he is worker .
4. Ahmed Zewar Mohammad Khalil – born at 1990 , he is student in intermediate school .



Then after they had killed all the men inside the house the mother ( Kareema Khalil ) and her daughter had stayed alone then the soldiers had threaten the women if they did not guide them to another sons' house they would rape them that what the translator told the mother so under pressure and obligatory the women guide them to the Nazar and Rabee's house and the same thing the forces attacked the house with fire and bombs then they arrested the two sons to unknown side and they toyed with all furniture inside the house . After the forces had withdraw , the jewels ( 10,000,000) ten million Iraqi Dinars .

The arrested victims are :

1. Nazar Zewar Mohammad Khalil , his birthday is 1979 he is student in Islamic code (Al-sharea college) .
2. Rabee Zewar Mohammad Khalil – his birthday is 1981 he is married , he has one child and he is worker .

So , the I.O.H.R needs more inquiry and illustration and punish the criminal soldiers and this incident is regards a serious violation according to Geneva agreement and the rules of the international humanitarian law .

In a view of passing four days of this serious crime and till how the multi-national forces don't issue any comment on this incident . So the I.O.H.R. decided to spread this report of this serious violation .

Finally the I.O.H.R. demands the united nations mission in Iraq , all human rights organizations and all whom it may concern from the violations .
